#### **Minutes**

Mary Huston made a motion to approve September 20, 2021 UCC meeting minutes as written and seconded by April Warren. Meeting minutes approved as written.

Dannah Schaffer, Chair of Committee for the Evaluation of Teaching – Feedback on advising assessment and adjunct evaluation – see files in Teams folder

- Question was asked about how often a chair would need to attend a class period of new adjunct faculty member to see how they are doing.
  - At least one time within the first semester of teaching.
  - Must be informed of their observation at least two weeks prior to the date and full-time faculty member of the Academic Unit Chair to observe.
- Advisor evaluation Chairs provided some feedback. Dannah will take it back to the Committee for the Evaluation of Teaching for discussion and revisions.

### Overloads – see current policy

- Can we clear up course overloads? What has changed in the last 10+ years that people are getting more overloads when we have over 600 fewer students? Discussion was held about workloads and other issues.
