

Advising Student Athletes

Application for Graduation

The new online Application for Graduation is available at:

https://www.minotstateu.edu/records/forms.shtml

Students do not need to meet with advisors to complete the Application for Graduation, unless advisors wish to at their discretion. Upon receipt of the application, if there are any conflicting questions between what was submitted and the program plan, the Registrar's Office will contact the student and follow up with the advisor.

Once the application is processed, an Acknowledgement email will be sent to the student, advisor, and administrative assistant. The first audit is completed within a few weeks after early registration begins. It is important for students to enroll in their classes in a timely manner, so their audit is accurate. An Eligible to Graduate or Missing Requirements email will be sent to the student, advisor, and administrative assistant. The final audit is not completed until after final semester grades are posted. If all requirements have been met, the degree will be posted. In cases where something is missing, the advisor and administrative assistant will receive the Final Department – Missing Requirements email. If the issue is not resolved within two weeks, the student is sent an email and letter stating their missing requirements. If the degree cannot be posted by data freeze, a copy of the graduation application and a letter explaining the situation will be sent to the department.

Spring Registration

Early registration for current students will take place between **November 5-7**. Students can now view their earliest registration date and time in Campus Connection. Students should be reminded to take care of any holds they may have, as many holds do prevent registration (i.e. Delinquent Account, Advisor, Department, Financial Obligation Agreement, Student Health, Prevention Violence Training (PVT), etc.). Now is a great time to reach out to your advisees and encourage them to schedule an appointment so you can start planning for the upcoming semester!

FERPA Release Information

Before disclosing information to a third party, advisors must check Campus Connection for FERPA release information. This can be found by:

- Logging into Campus Connection.
- Go to Advisor Center.

• Click View Student Details next to the student from which you wish to view the FERPA Service Indicator.

• Choose the general info tab at the top.

• Under Service Indicators, click on the appropriate FERPA Release (All, Academic, or Financial). If no FERPA Release is listed, do not share student information.

• Confirm the question is answered correctly and the name of the individual requesting information is listed in the comments. If information does not match, do not release student information.

Spring 2019 First-Year Experience (FYE) Learning Communities

Students who Pre-Registered

An email will be sent to students who preregistered for a spring FYE on Friday, October 18. The email is to let students know that the Registrar's Office will be officially enrolling students in their FYE courses by November 1! In order for the Registrar's Office to add students to their classes, they will need to make sure they do not have any holds in Campus Connection.

How Students Enroll

Students who still need to enroll in the spring FYE should first meet with their advisor to determine which FYE is appropriate. A list of learning communities offered in the spring semester can be found at

https://www.minotstateu.edu/cetl/first_year_experi ence.shtml. After visiting with their advisor, students will contact the Academic Support Center (Gordon B. Olson Library, lower level) to register.

Repeating the UNIV 110

A stand-alone online 2 credit UNIV 110, Power of a Person, will be offered in the spring semester for students who are online only students and for those who did not successfully complete their initial attempt at the course. Students can also retake the UNIV 110 in another learning community, but they must take the course(s) linked to that UNIV 110, as well.
