New Business

1. Senate Reports

Faculty Senate

We hosted an excellent Great Plains Symposium last week and Kevin thanked the many people involved in the production of this event. Assessment Day was held last week; have several ad hoc committees working a variety of different issues.

Staff Senate

The Staff Senate's Power of 100 project is to donate 100 hours of volunteer service in the community – so far they have 41 hours accrued; several different offices around campus are holding their own Power of 100 projects; meeting with Warren Gamas to set up a sub-committee for the UPPC to look at the administrative side; committees will be asked to be more active to help move the senate forward; holiday decorating contest will be coming up soon – looking for a centennial tie-in.

The Fuller's hosted SGA for their last meeting which included some leadership development exercises; next week's meeting will include a focus session from the Planning & Budgeting Council to get student's opinion on what MSU's focus should be in the coming year; September SGA Scoop is available on line; will be involved with Halloween at the Dome – all clubs are involved.

Still a lot of conversations going on regarding Pathways; Mike Hillman, the interim Vice Chancellor for Academic Affairs will be done the beginning of November; switching over to the new tuition model will be very complicated; we need to market this and roll out changes as soon as we can; still not sure of all

the impacts this will have; looking at making our admission standard more transparent – right now the NDUS only publicizes the high end number (190) and students would not know that they would qualify with a number in the 170-189 range.

4. Other

Sexual Harassment Prevention Workshops – these will be held on October 23 and various 1-hour sessions will be held throughout the day. This training is mandatory and if someone is unable to attend they must provide a very good written reason for not attending. Will need to look at conducting a make-up session at a later date. Training is being conducted by the Village Business Institute.

State Van Usage – there have been some questions about what constitutes a university sanctioned activity and the use of vans by students to attend these functions. From a risk management standpoint, there is a liability to the state should something happen. Brian will get out clear and definitive guidelines for all the campus to avoid any confusion in the future.

Budget Issues – there has been some talk of restoring the budgets to the previous levels prior to the cuts we made the past couple of years – in particular in relation to the library. The library did an extensive review of their operations and budget and made their own cuts that would still not sacrifice services. Some of these will be replaced in the future. Brian is available to talk to Faculty Senate to help explain the issues involved with budgeting.

Wellness Center – we are opening the discussion of expanding usage to the wellness center facility among other campus members. A number of meetings will be held with not only those on campus but also community entities to seek input. Recommendations will be made to the Cabinet and to President's staff.
