New Business

1. Senate Reports

<u>SGA</u>

- SGA has new senators as of yesterday:
 - o Ella Gilkerson President
 - Drew Manley VP Finance
 - Nicole Reeves VP Internal Affairs
 - Krista Permentier VP State Affairs
- We have retained a good number of current senators going into next year
- Hosting a graduation drive for donations of caps and gowns that people no longer need to give to those
 who don't have one

Faculty Senate

- The 2025-2026 catalog does have the updated Gen Ed program
- Last faculty senate meeting was extra-long as changes to the constitution and by-laws were reviewed due to the academic restructuring
- Have provided testimony on HB1220 relating to creation of accelerated degrees for high demand occupations; this failed in the Senate
- Have also testified on HB1437 that would create and enact a new section to chapter 15-10 of the ND Century Code, relating to academic tenure policies at NDUS institutions; is with Governor

Staff Senate

- Silent Auction is underway in the Conference Center; will have a live auction at 11:00 today for donated baskets
- Will offer chair yoga on April 28
- Elections will be held next week

2. President's Report

- The higher education bill going through the legislature is SB2003; the Senate did not allow for any funding for the joint MSU/DCB request to purchase the Trinity building but the House did so it will need to go back to subcommittee
- House has been very good with also budgeting \$8M from the last session to renovate academic areas in Model and Moore Hall
- Tried to get funding for a new residence hall at DCB, which would have replaced those they currently
 have; that was not granted but they did budget for some renovations to the existing halls
- Challenge Grant is looking good as well as salaries still holding at 3:3 for the next biennium
- House did budget \$650,000 for Dakota Hall; Rep. Louser has been helpful with all of these items
- House added a max of a 4% increase for tuition
- AStep received some nice support to grow that program across the state; we had people testifying for the funding
- SPBC has presented their recommendations to President's Staff; decisions will be made over the next several weeks and will hold a budget forum before graduation to go over results

3. Acknowledgements/Announcements:

International – with the administration's focus on Homeland Security, international students have to be extra careful that their SEVIS information is up to date; there is a lot of uncertainty causing anxiousness among students; the International office is creating protocols on what to do should a student receive a termination; they need to keep their I20 and I24 with them at all times because these prove that they are students and are here through the proper process; the International office has been very busy fielding questions and keeping up with changes taking place

Advancement – had a successful Giving Day – still verifying totals but we did get up to \$450,000; put in a lot of work to make this happen; Board of Regents are meeting on May 9th and Governor Armstrong has tentatively agreed to be the keynote speaker; we will keep the campus informed so those that want to listen to him can do so

Library – egg hunt is underway today; two librarians returned from a conference in Minneapolis; received an award for being a Federal Deposit Library for 100 years

Plant – working on the Dome parking lot; have a backlog in workorders so please be patient; need to be more attentive when setting events and getting the set-up information to plant in a timely manner – don't wait until right before your event takes place

VPAF – busy with legislative business and budget

Athletics – we have a new camps web site; the nutrition center is moving along; will host an open house for the new golf room; BESPY awards will take place on May 5

Alumni – the following will be honored the fall Golden Awards Banquet: Randy Hedberg, Lisa Johnson, Don Selk, Greg Blikre, and Joe Davis; Gala is May 9; will host a Senior Sendoff on May 13; summer events are on the calendar; will send a save the date for Homecoming week in September

Wellness – hosting a blood drive today from 12:30 - 4:00; will have another on May 2; May Marathon will run through the month of May; working on getting food trucks for the summer

Student Center – finals breakfast on May 12 – please sign up to help

ASC – helped with new student registration last week

Power – received 15 applications from the resource fair held last week during registration; waiting to hear on refunding of the program – hopefully know in June; had a great turnout for Dr. Shaun Tyrance's presentation on wellness and keys to high performance; participated in Giving Day and received \$3,400 which will be used for equipment to help engage online students better and give them a sense of belonging; received advice from ND Trio on how to contact legislators regarding possible cuts to the program under the current administration

MRC – attended several workshops; welcome home Vietnam Vets; Grad Expo & Resource Fair; will attend Prairie Warrior Auction on April 24; looking into local energy groups for internships; looking at Navy scholarships; MSU recognized by Minot Area Chamber EDC for outstanding military support of Minot Air Force Base

Bookstore – regalia is available; have new products coming in; Joseph will be done in August as he will be completing his in-classroom preparation for the School Psych – Ed Specialist Degree he is completing

Financial Aid – still FAFSA season; hosted the State Financial Aid Directors conference in Minot last week

Business Office – the new purchasing person has started; J. Lehman will now be doing accounts payable

IT – must move to Windows 11 in October 2025; received money through the legislature for upgrades

NDCPD – Money Follows the Person grant helped relocate 60 people in Fargo to accessible housing; May 15th we will honor five Astep students who will be graduating this year; will celebrate our 35th anniversary this fall with various events

Assessment – using AI to help facilitate program assessment while keeping the human in the loop; SPBC Dashboard related to relativity and effacing of programs; working on compiling all information in one area

NA – recruitment event at TMCHS and a virtual meeting with Ft. Peck in MT; will host a cultural presentation on Friday, April 25th prior to the Powwow – still looking for volunteers to help with powwow on April 25 and 26; STEAM day on Saturday April 26

Housing – opened enrollment for residence halls; attended a conference for conduct tracking

Enroll/Market/Outreach – C. Krueger is out for two weeks – contact J. Mrozik for assistance; College for Kids is preparing for summer courses

Enrollment – had 138 students register on April 9; next session is on April 24; hired a new admission specialist; E. Norman is leaving the department

DCB – looking for a dental director for the program in Minot

VPAA – poster session on April 24 in the library; tenure and promotion candidates have been approved

Registrar – the Grad Expo was a success with around 100 students participating; will be contacting non-returning students to get them to register; Alum Commencement speaker will be V. Pinnick

HR – get evaluations in; NDUS has had some changes in personnel due to addition of DSU and LRSC to their payroll processing
