## The MSU Staff Senate Scholarships Criteria

As of January 21, 2000, the Minot State University employees established the MSU Staff Senate Scholarship Endowment Fund. For the Spring 20 semester, the scholarship application is available on the Staff Senate website. **Completed** applications must be returned to the Financial Aid Office by 4:00 p.m. on Friday, December 11, 2020.

The fund's purpose is to assist staff or their dependents in their educational pursuits at the university. Dependents include spouses or unmarried children under the age of 24. To be classified as an employee's dependent, the student must be claimed as an exemption on the staff member's federal income tax return.

## Criteria

- Employment with MSU for a minimum of one year by the start of the term of the scholarship award.
- Enrollment in at least one MSU credit for the term of the scholarship award.
- Staff must have a minimum cumulative GPA of 2.5 or be a first-time student.
- Dependents must have completed 24 or more semester credits, maintaining a minimum cumulative GPA of 2.5.
- Applicants eligible for scholarship in consecutive academic years at discretion of the scholarship committee.

- Books and supplies
