Catalog Description: This mid-level clinical experience provides students in Teacher Education with an extended experience in the fall semester observing and assisting with beginning of the year room design, organization, and classroom management policies and procedures. This course is typically taken with a methods class or student teaching.

Grading Policy and Scale:

GRADING SCALE

This course is an S/U graded course. In order to earn an “S,” teacher candidates must complete the appropriate number of days for the experience, have those hours verified by the cooperating teacher, complete the self-assessment in SLL, and upload the observation guide to SLL. In addition, teacher candidates must earn at least a 2 on all the categories of the activity from the cooperating teacher and the university supervisor. Pre-service teachers who do not earn a 2 in all categories will need to work with the Director of Teacher Advisement and Field Placement to develop a plan to remedy the concerns

The ED 324L activities are due on September 15.

Tentative Course Outline:

Teacher candidates in practicum will spend 2 days helping the teacher either set up the classroom OR 2 days attending workshop sessions AND the first 2 days of school with the teacher. Student teachers will be at the school for the assigned dates of their placement.

Minot State University is committed to academic honesty and integrity. Academic dishonesty includes, but is not limited to, the following types of behaviors:

- Misrepresenting work of others, including AI, as one's own.
- Using the product of generative or other forms of AI unless permitted in a course assignment or syllabus.
- Copying from another student during an exam.
- Altering one's exam after grading for the purpose of enhancing one's grade.
- Submitting the same work to more than one class without the prior approval of the instructors.
- Use of any material or device not approved by the faculty during an exam.
- Falsifying field collection or research data.
- Failing to maintain professional standards for ethical research and practice.
- Violating the confidentiality of clients or participants.

Incidents of academic dishonesty will be documented by the faculty member and the department chair notified. Students will be notified with an explanation and consequences in accordance with the faculty member's grading policy as outlined in the syllabus. The student may appeal the faculty member's decision to the department chair. Student disciplinary action may result in accordance with the Student Handbook.

Reporting Process:

Step 1: Student commits academic dishonesty.

Step 2: Instructor will enforce their academic honesty policy according to their syllabus.

Step 3: Instructor raises Academic Honesty flag in Starfish for the course and includes supporting details as well as the consequence. The Starfish flag and communications serve as notification to the Department Chair, the Vice President of Student Affairs (or designate), and the student.

Step 4: After three Academic Honesty flags have been raised on one student across their academic career, an investigation is opened by the Vice President of Student Affairs (or designate). Student disciplinary action may result in accordance with the Student Handbook. In exceptional cases, the Department Chair may request the Vice President of Student Affairs (or designate) and Vice President for Academic Affairs to open an investigation, regardless of the number of raised flags.

Penalty for Violating the Policy

When plagiarism occurs, a failing grade will be given for the assignment and further action may be taken following MSU guidelines regarding academic honesty. Copying material from sources either printed or electronic, or another student, whether from this semester or a previous one, is unacceptable. If this occurs, you will receive a zero on the assignment and I will raise an academic honesty flag in Starfish and potentially refers the student to TEAC. I am usually unable to

distinguish between the person who copied and the person who was copied; therefore, you are STRONGLY ADVISED not to share your coursework with ANYONE. If a friend is missing material or doesn't understand something, please advise them to come see me and I will help them. Copying another person's work may have additional consequences, including a referral to Student Life and possible probation at Minot State University. ED 324L Clinical VI is an extended experience in the fall semester observing and assisting with beginning of the year room design, organization, and classroom management policies and procedures. You will spend 4 school days total in this clinical. You must have a set schedule in advance for these observation periods and you must stick to that established schedule. If illness or another major event causes you to be unable to attend on a particular day, it is your professional responsibility to notify your university instructor (for the first half of this experience) and your classroom teacher. You are required to maintain a reflective journal for this experience and submit a final reflective paper, as well as a self-assessment form (Mid-Level Clinical VI), to the Tk20 system. ED 324L Connections: Methods and student teaching are complementary courses to ED 324L Clinical VI. ED 324L provides teacher candidates with the opportunity to observe and participate in the process of getting ready for a new school year and setting up procedures for the school year. Methods and student teaching allow the teacher candidate to participate in those processes and make the connection between how classrooms are set up and how they function.

The teacher as reflective decision-maker is the organizing theme of teacher education programs at Minot State University.
