STEM Students: You may be eligible for additional benefits

If you're a Veteran using the Post-9/11 GI Bill or a Fry Scholar, you may be eligible for additional benefits of up to nine months or \$30,000. You must:

- 1. Be enrolled in a qualifying STEM program.
- 2. Have completed a certain amount of time on your degree.
- 3. Have six months or less of your benefits left (if you apply too soon, you'll be denied).

James's Corner

Hello, everyone!

Hello to our new and returning students,

This month I wanted to discuss the importance of being on time with your semester worksheets and any updates to your enrollment. It is crucial that you get your semester worksheets submitted promptly after you enroll in your courses. This ensures that your monthly payments and book stipends (if applicable) are paid on-time. When we get late submissions (after the term has started, e.g.), you should not be surprised if your payments aren't received right away, as the VA works on enrollments in the order they are received. Also, it is important that you let our office know when you make any changes so that I can make the changes with the VA to prevent any potential overpayments which could land you in debt with the VA and/or Minot State. Additionally, we have been seeing a lot of students emailing and calling about not receiving their monthly payments. If you recall your Student Agreement meeting, the second paragraph on the first page mentions that you need to call the VA with any specific benefits questions, to include any information about your monthly payments. Our office is not involved in your monthly payments so we unfortunately cannot help with any payment questions.





Are you eligible for the GI Bill tutoring benefit?



If you're having trouble in a required subject and need a tutor, you can be reimbursed by the GI Bill for up to \$100 a month and a maximum lifetime limit of \$1,200. You're eligible if you're studying 51% or more full-time. Full-time for an undergraduate student is typically 12 credit hours, while it will vary for graduate students.

Minot State Writing Center

The Minot State Writing Center is now open for tutoring for the Fall 2025 semester. The Writing Center offers both in-person and online (asynchronous or synchronous) tutoring. Check the tutor's availability when you make an appointment. To make an appointment, individuals MUST log in or register for an account at https://minot.mywconline.com. If you choose e-tutoring (asynchronous), remember to attach your paper using the links at the bottom of the appointment form. The tutor will comment on your paper and email it back. E-tutoring (asynchronous) individuals do not need to come to the Writing Center. Online tutoring (synchronous), will need to be at their computer, logged into WC Online, at the appointment time and day. You and the tutor will communicate live via audio, video, and text. Space Force members must apply for TA online on the website of the Air Force Virtual Education Center (AFVEC) (https://afvec.us.af.mil/afvec/public/welcome).
Department policy requires members to create a goal and upload a degree plan prior to requesting TA (see the "Tutorials" on the AFVEC site). Students may upload a generic degree/academic as a placeholder for up to six semester hours until an evaluated degree plan is in place.

Chap 35 enrollment verification update

You must verify your enrollment every month to receive your benefits for Survivors' and Dependents' Educational Assistance (DEA or Chapter 35). Find out how to verify your enrollment.

How do I verify my enrollment for DEA?

1) By email

If you choose to verify your enrollment each month by email, we'll send a message to the email address we have in our records for you.




